### **VENDOR TERMS AND CONDITIONS**

Cape Fear Festivals agrees to permit Vendor (heretofore Charities as well) to rent a booth during the Cape Fear Beer and Wine Festival. In consideration of the foregoing and of the promises and mutual covenants herein, the parties agree as follows:

#### 1. HOURS OF OPERATION.

Vendor booths must be fully staffed, and must remain fully staffed, and prepared to serve attendees on Saturday, March 9, 2019 from 12:00 p.m. to 5:00 p.m. Set-up will begin at 9:30 a.m. on Saturday, March 9, 2019, and must be complete no later than 11:30 a.m.

### 2. BOOTH SIZE.

Booth size will be 8 feet wide by 8 feet deep for Vendors. Vendor understands that the festival, in its sole discretion, will assign space.

### 3. ELECTRICAL SERVICES.

The festival will not be providing electricity as part of the booth rental fee.

### 4. LOAD-OUT.

All materials must be removed from the grounds by 6:00 p.m. on Saturday, March 9, 2019.

### 5. INSURANCE.

All Vendors must have and maintain the appropriate applicable liability insurance coverage as required under North Carolina law for the sale of goods or services.

### 6. PUBLICITY.

Upon receipt of payment and Registration approval, Vendor agrees to allow use of names, likenesses, and other materials as may be deemed appropriate for advertising, publicity, or marketing promotion of the Festival without compensation. Vendor may be asked to link to our website and social media to help us promote the festival and your product or service.

### 7. SIGNAGE.

Vendor may only display its own business signs and banners within the assigned booth space.

### 8. CONDUCT.

Behavior unsuitable for the festival or which constitutes a public nuisance will not be permitted. Vendors will not engage in loud, live or recorded music during the festival.

### 9 CONTENT.

Nothing can be sold, distributed or displayed that can be construed as unlawful, threatening, libelous, defamatory, obscene, scandalous, inflammatory, pornographic, or profane, or any other material that

could give rise to any civil or criminal liability under the law.

### 10. CANVASSING.

Vendors may canvass only from inside their booth space. Canvassing from outside of the booth space is not permissible.

### 11. SECURITY.

Vendors are responsible for the security of their own property and equipment at all times. No security personnel will be assigned specifically to Vendors. The festival shall not be held responsible for loss, theft or damage to any property. The festival shall not be held responsible for loss, theft or damage to any property left on the grounds at any time.

### 12. VIOLATIONS.

Vendor acknowledges that a breach of any of the terms of this Agreement may result in the termination of this Agreement and the preclusion of the Vendor's participation in the festival. In the event this Agreement is terminated as a result of any breach by Vendor, Vendor shall not be entitled to any refund but shall forfeit all amounts previously paid as liquidated damages.

### 13. LIABILITY.

Vendor shall indemnify and hold the festival, the festival staff, contractors and volunteers harmless from any claim or cause of action arising out of or in connection with the acts or omissions of Vendor under this Agreement, and shall reimburse the festival for any costs, including but not limited to, reasonable attorney's fees incurred in defense against any such claim.

### 14. CANCELLATION.

Vendor understands in the event the Vendor cancels, the entire booth fee will be forfeited.

# 15. RESOLUTION OF DISPUTES.

In the event of a dispute arising in any manner as a result of, or in any way related to, this Agreement, the parties hereto agree to submit the same to mediation and/or arbitration as a prerequisite to legal action. In the event arbitration or legal action is commenced, the prevailing party shall be awarded reasonable attorney's fees and costs incurred a result of said dispute.

### 16. BOOTH ACCESS.

The festival and its agents or assigns shall have access to the aforesaid described space and premises at all times. Booth space cannot be assigned or leased by any organization other than the festival management.
